

The application/smil Media Type

Abstract

This document specifies the Media Type for version 1 of the Synchronized Multimedia Integration Language (SMIL 1.0). SMIL allows integrating a set of independent multimedia objects into a synchronized multimedia presentation.

1. Introduction

The World Wide Web Consortium has issued a Recommendation [[1](#)], which defines version 1 of the Synchronized Multimedia Integration Language (SMIL 1.0). This memo provides information about the application/smil Media Type.

The definition is based on the RFC defining the use of the "application/xml" media type [[3](#)]. Before using the "application/smil" media type, implementors must thus be familiar with [[3](#)].

2. Synchronized Multimedia Integration Language

SMIL allows integrating a set of independent multimedia objects into

a synchronized multimedia presentation. Using SMIL, an author can

1. describe the temporal behavior of the presentation
2. describe the layout of the presentation on a screen
3. associate hyperlinks with media objects

SMIL is defined using XML [2], and the definition of the SMIL media type is based on the definition of XML media types [3].

All of the considerations for "application/xml" media type [3] also apply to the SMIL media type. The relevant paragraphs are copied below for convenience:

Although listed as an optional parameter, the use of the charset parameter is STRONGLY RECOMMENDED, since this information can be used by XML processors to determine authoritatively the character encoding of the XML entity. The charset parameter can also be used to provide protocol-specific operations, such as charset-based content negotiation in HTTP. "UTF-8" [RFC-2279] is the recommended value, representing the UTF-8 charset. UTF-8 is supported by all conforming XML processors [REC-XML].

If the XML entity is transmitted via HTTP, which uses a MIME-like mechanism that is exempt from the restrictions on the text top-level type (see [section 19.4.1](#) of HTTP 1.1 [RFC-2068]), "UTF-16" (Appendix C.3 of [UNICODE] and Amendment 1 of [ISO-10646]) is also recommended. UTF-16 is supported by all conforming XML processors [REC-XML]. Since the handling of CR, LF and NUL for text types in most MIME applications would cause undesired transformations of individual octets in UTF-16 multi-octet characters, gateways from HTTP to these MIME applications MUST transform the XML entity from a text/xml; charset="utf-16" to application/xml; charset="utf-16".

Conformant with [RFC-2046], if a text/xml entity is received with the charset parameter omitted, MIME processors and XML processors MUST use the default charset value of "us-ascii". In cases where the XML entity is transmitted via HTTP, the default charset value is still "us-ascii".

Since the charset parameter is authoritative, the charset is not always declared within an XML encoding declaration. Thus, special care is needed when the recipient strips the MIME header and provides persistent storage of the received XML entity (e.g., in a file system). Unless the charset is UTF-8 or UTF-16, the recipient SHOULD also persistently store information about the charset, perhaps by embedding a correct XML encoding declaration within the XML entity. Although listed as an optional parameter, the use of the charset parameter is STRONGLY RECOMMENDED, since this information can be used by XML processors to determine authoritatively the charset of the XML entity. The charset parameter can also be used to provide protocol-specific operations, such as charset-based content negotiation in HTTP.

"UTF-8" [[RFC-2279](#)] and "UTF-16" (Appendix C.3 of [UNICODE] and Amendment 1 of [ISO-10646]) are the recommended values, representing the UTF-8 and UTF-16 charsets, respectively. These charsets are preferred since they are supported by all conforming XML processors [REC-XML].

If an application/xml entity is received where the charset parameter is omitted, no information is being provided about the charset by the MIME Content-Type header. Conforming XML processors MUST follow the requirements in [section 4.3.3](#) of [REC-XML] which directly address this contingency. However, MIME processors which are not XML processors should not assume a default charset if the charset parameter is omitted from an application/xml entity.

Since the charset parameter is authoritative, the charset is not always declared within an XML encoding declaration. Thus, special care is needed when the recipient strips the MIME header and provides persistent storage of the received XML entity (e.g., in a file system). Unless the charset is UTF-8 or UTF-16, the recipient SHOULD also persistently store information about the charset, perhaps by embedding a correct XML encoding declaration within the XML entity.

Encoding considerations:

All of the considerations for "application/xml" media type [[3](#)] also apply to the SMIL media type. The relevant paragraphs are copied below for convenience:

This media type MAY be encoded as appropriate for the charset and the capabilities of the underlying MIME transport. For 7-bit transports, data in both UTF-8 and UTF-16 is encoded in quoted-printable or base64. For 8-bit clean transport (e.g., SMTP, 8BITMIME, or NNTP), UTF-8 is not encoded, but UTF-16 is base64 encoded. For binary clean transport (e.g., HTTP), no content-transfer-encoding is necessary.

Security considerations:

SMIL documents contain a construct that allows "infinite loops". This is indispensable for a multimedia format. However, SMIL clients should foresee provisions such as a "stop" button that lets users interrupt such an "infinite loop".

As with HTML, SMIL documents contain links to other media (images, sounds, videos, text, ...) and those links are typically followed automatically by software, resulting in the transfer of files without the explicit request of the user for each one. The security considerations of each linked file are those of the individual registered types.

In addition, SMIL has some of the same security considerations as specified in [3], with the following exceptions: the section on XML entities does not apply, since SMIL 1.0 disallows entities.

Interoperability considerations:

SMIL documents contain links to other media objects. The SMIL player must be able to decode the media types of these media in order to display the whole document. To increase interoperability, SMIL has provisions for including alternate versions of a media object in a document.

Additional information:

Semantics of fragment identifiers in URIs: The SMIL media type allows to append a fragment identifier to a URI pointing to a SMIL resource (e.g. <http://www.example.com/test.smil#foo>). The semantics of fragment identifiers for SMIL resources are defined in [1].

Magic number(s): none

All of the considerations for "application/xml" media type [3] also apply to the SMIL media type.

File extension(s): .smil, .smi, .sml

NOTE: On the Windows operating system and the Macintosh platform, the ".smi" extension is used by other formats. To avoid conflicts, it is thus strongly recommended not to use the extension ".smi" for storing

SMIL files on these platforms.
