- With the adoption by NETCONF and NETMOD of the revised datastores model, I2RS can complete its tasks
  - Complete the ephemeral datastore model
  - Submit all main models to IESG
  - Go into Hiatus (aka dormant state)
- Plan to complete this by March 2018
