- We had a small Charter Update since our last meeting to avoid problems due to the previous interlock between getting rfc6126bis out and producing a YANG model.
 - With the change, the YANG model can be done later as a separate item and is now a SHOULD rather than a MUST.
 - This does not effect the Information Model draft which is moving along.
