"Considerations for Having a Successful Birds-of-a-Feather (BOF) Session"

• Is there a problem that needs solving?

– Is the IETF the right group to attempt solving it?

- Is there a critical mass of participants willing to work on the problem (e.g., write drafts, review drafts, etc.)?
- Is the scope of the problem well defined and understood. That is, do people generally understand what could be worked on (and what not!)

– Is it clear what the deliverables would be?

• Is there a reasonable probability of success tackling this problem and producing these deliverables?

# Questions We Need to Answer

- Do we understand the deployment models?
  - Different operators may have different use cases
- Are we clear on the scope and requirements?
  - Requirements are driven by the use cases
  - What is out of scope?
- Does any work belong in the IETF?
  - What?
- If we do work in the IETF, should it be in RTGWG or in a new WG?
- How can we best cooperate with the BBF to ensure our requirements are in step?
- Do we have enough people to review and progress the work?
  - This needs intent to implement and deploy
- Do we want to solutions optimised for specific use case, or do we want a general solution to fit all deployments?
- Is this a short (18 to 24 months) piece of focused work
  - Potential to re-charter after delivery
  - Or does it need to be more open-ended?
- Keep these questions in mind during the BoF
