(last face to face meeting)

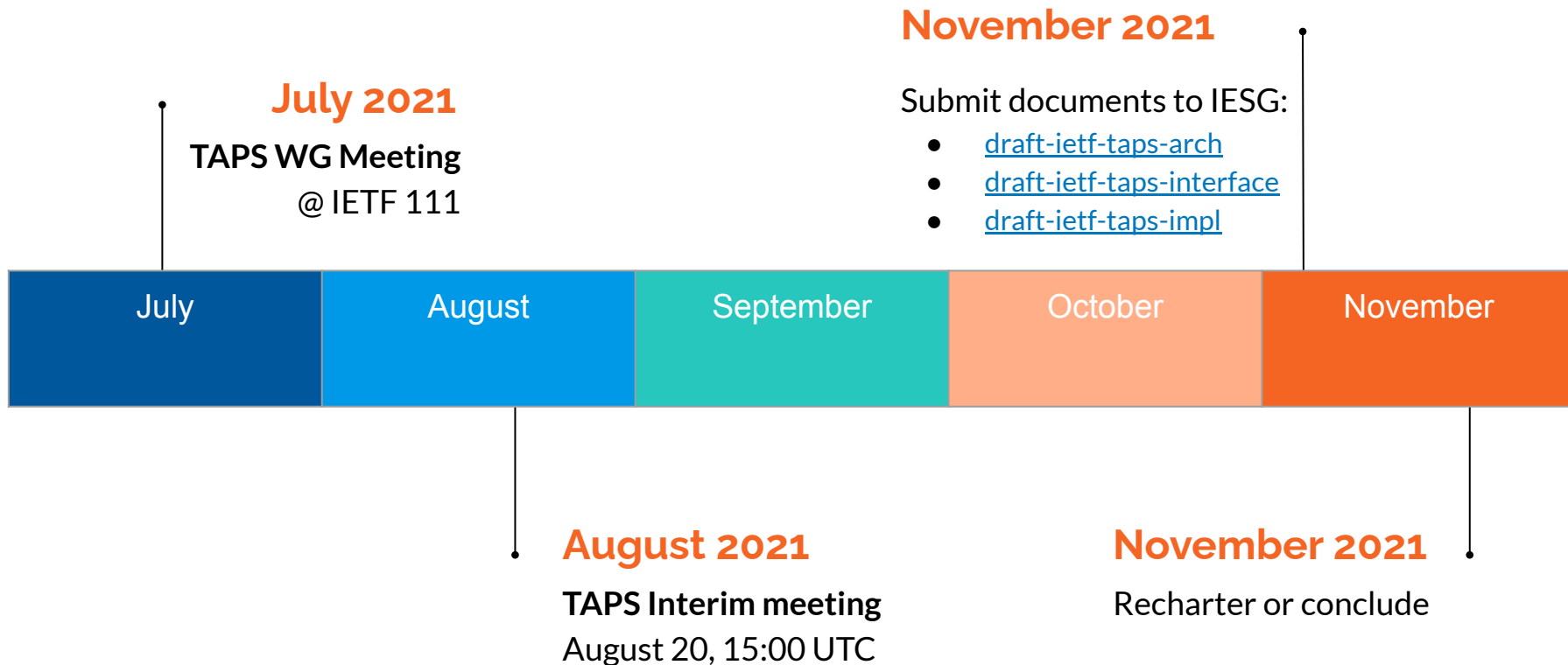
- Published [RFC 8922](#) (A Survey of the Interaction between Security Protocols and Transport Services)
