To summarise our charter https://datatracker.ietf.org/wg/quic/about/

The WG acts as the focal point for any QUIC-related work in the IETF.

- 1. maintenance and evolution of the existing QUIC specifications
- 2. supporting the deployability of QUIC
- 3. new extensions to QUIC

How new or existing application protocols use QUIC can be done outside our WG, or done here if needed.

Defining new congestion control schemes is explicitly out of scope for the WG.
