Our Charter Talks About a Liaison

- **This working group will:**
 - publish a standard text serialisation format for the context in which the timepoint exists which:
 - is a companion to RFC 3339 rather than a replacement;
 - embeds unaltered RFC 3339 data in a way that makes it easy to parse just the datetime;
 - is able to round-trip through intermediate systems which do not understand the full context
 - coordinate with ECMA International TC39 and ISO/TC 154 to ensure that this work remains a strict extension of ISO 8601
- **Chairs did a short presentation to IAB requesting liaison on August 25, 2021.**
- **IAB agreed to setting up a liaison on October 5, 2021 and requested volunteers.**
- **On October 22, IAB started the process of selecting a candidate for the liaison.**
- **No further information since then, however the chairs will follow up during IETF 112.**
