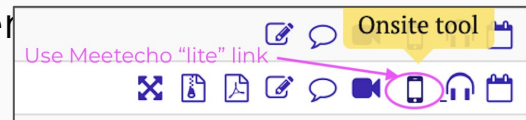

## WG drafts waiting to be sent to IESG:

- draft-ietf-i2nsf-consumer-facing-interface-dm-16  
**Need WG discussion if consumer facing DM needs to be consistent with NSF facing DM.**
- draft-ietf-i2nsf-registration-interface-dm-14
