- draft-iab-use-it-or-lose-it published as RFC 9170
- Interim meeting on February 1, 2022
  - Added a datatracker tag "related\_implementations" to help highlight implementation status, interop testing, and code
  - Planning on reviving draft-iab-protocol-maintenance

# Internet Threat Model (model-t)

- Interim meeting on December 7, 2021
- A document update + discussion on mailing list since then
  - Converging on publishing IAB document(s) on principles surrounding data minimization and involvement of intermediaries?
  - But work remains on those, and if we want to update IETF threat models that needs to be done separately

# The RFC Editor Future Development Program

### RFC Editor Model v3 is ready to be approved!

- The RFC Editor Future Development Program concluded its work beginning of February.
- After a four weeks IAB community feedback call and review by IAB and IESG draft-iab-rfced-future-rfced-model-13 was published recently to address all comments.
- The final version of the new RFC Editor Model (Version 3) will be approved and published together with three related documents in the the IETF stream:
  - draft-carpenter-rfced-iab-charter (IAB Charter Update for RFC Editor Model)
    - Currently undergoing a second IETF Last Call
    - Also needs to be approved by the ISOC Board of Trustees (on the agenda of the post-113 meeting)
  - draft-rsalz-2028bis (Entities Involved in the IETF Standards Process)
  - draft-rosen-rfcefdp-update-2026 (RFC Series Responsibility Change)

Thanks to everybody in the program, everybody who reviewed the draft, the editor Peter Saint-Andre, and the chairs Eliot Lear and Brian Rosen!

### Liaison Updates

- The Multi Stakeholder Platform on ICT Standardisation is up for renewal by the European Commission in May 2022.
- The ICANN Security and Stability Advisory Committee (SSAC) has published <u>SAC113</u>, calling for the ICANN board to ensure a DNS label is reserved for private use, which "must never be delegated."
- The ICANN Root Server System Advisory Committee (RSSAC)
  - Root Zone Maintainer is seeking feedback from the RSOs on the newly published ZONEMD Deployment Plan.
  - RSSAC058: a new document on "Success criteria for the Root Server governance model"
- The IAB is currently looking for a qualified volunteer to serve on the ICANN Root Server System
   Governance Working Group (GWG).
  - Deadline to volunteer is Monday, 2022-04-04.
