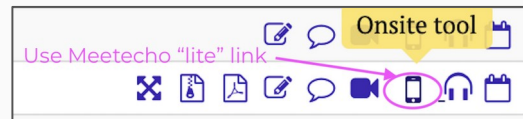
IETF 113 Meeting Tips
