(last face to face meeting)

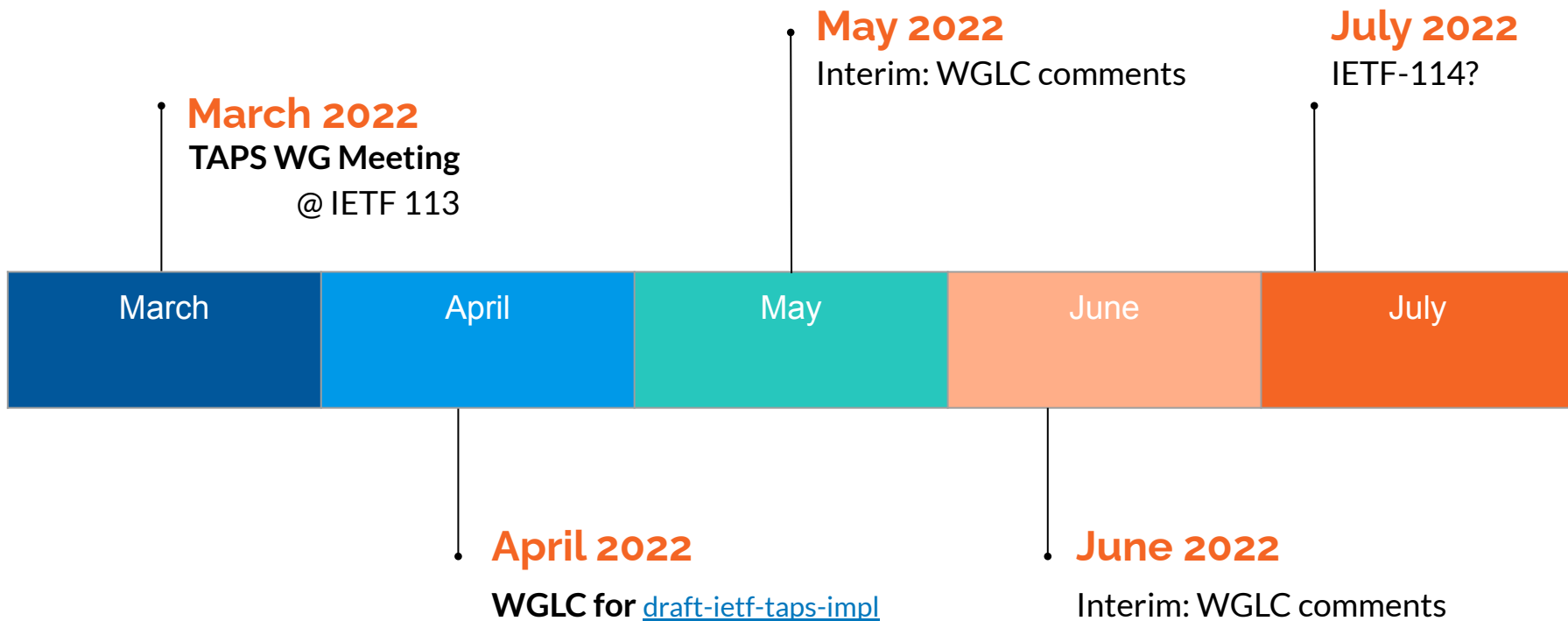
- Six interim meetings
