Errata

- A tracking system owned by the RFC Editor for recording mistakes in published RFCs
 - Makes a record of the correction, linked from the main RFC page
 - Can be folded in if a bis document is ever produced
- Used for:
 - Editorial mistakes
 - Errors in recording consensus
- Not used for:
 - "I think the document really should've said ..."

Errata

- A filed erratum needs to be processed by the responsible AD
 - Rejected, Verified, or HFDU
- They often are not, for a variety of reasons
 - ART: 340
 - APP: 177
 - RAI: 66
- We need your help to get these processed
 - Especially sponsored documents, or old WGs

Looking For Help

- Need help in a variety of roles
 - Protocol request reviewers w/IANA
 - e.g., media types
 - Document shepherds
 - Doesn't have to be a WG chair
 - Working group secretaries
 - Assist the chairs in tracking issues and recording consensus
