Charter proposal for ELEGY working group

- (We'll pick a better name...)
- The ELEGY working group will develop a best current practice (BCP) document that specifies the criteria for IETF NomCom eligibility going forward. The document will be informed by the RFC 8989 experiment, and will address meetings held in person, including hybrid formats, as well as those held remotely only. It will cover ONLY eligibility to volunteer for the NomCom. No other aspect of NomCom selection or operation is in scope.
- Milestone: 2022-11 Publication Requested for the BCP
