6. Contribute to the ongoing work of the group and the IETF

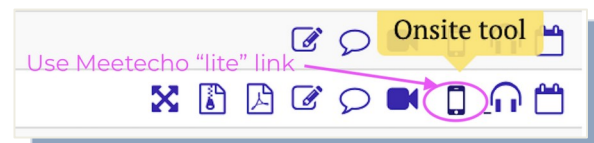
