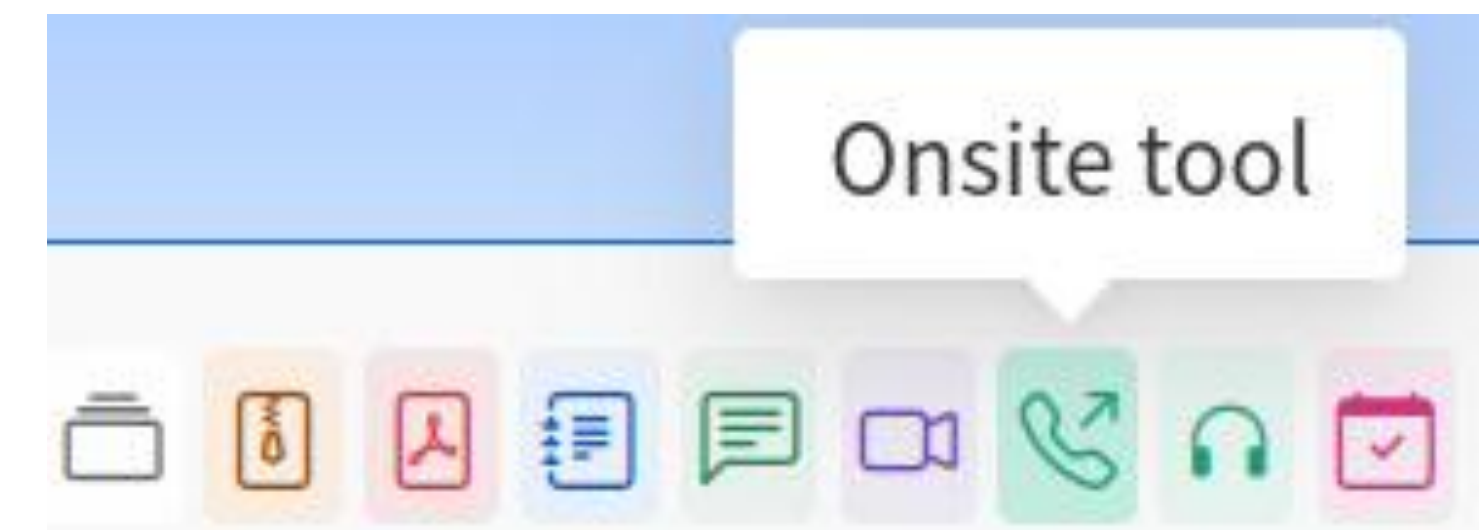

RFC 9290

- “Concise Problem Details for Constrained Application Protocol (CoAP) APIs”
 - A format for responses to unsuccessful requests
- *Was draft-ietf-core-problem-details*
- CoAP/CBOR analogy to RFC 7807 (HTTP/JSON)
 - 7807bis just finished IETF LC
 - Interesting: 7807bis uses IANA URIs as dereferenceable identifiers; can IANA offer this service?
