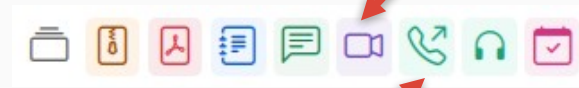
IETF 115 Meeting Tips
