In December, the IAB reappointed Warren Kumari to the ICANN Technical Liaison Group.

In January, the IAB re-appointed Colin Perkins for another term as IRTF Chair.

In February, the IAB appointed Charles Eckel as the new IETF Liaison Manager to 3GPP.

Also in February, the IAB appointed János Farkas as the new IETF Liaison Manager to IEEE 802.1.

In March, the IAB sent a liaison statement to ITU-T Study Group 13, Response to LS on the new work item Y.SAN "Requirements and architecture of service aware network".

#### **Liaison Report Highlights**

#### November 2022:

- The IETF-IANA Group met during IETF 115. Minutes from that meeting are available in the Datatracker.
- The IRTF Chair reported that nominations for ANRP 2023 closed on 18 November, with 65 nominations received.

#### December 2022:

- IANA reported that ICANN met 100% of processing goal times for the November 2022 monthly statistics report, exceeding the SLA goal to meet 90% of processing goal times.
- The IRTF Chair reported that a proposed research group on Usable Formal Methods is currently in IRSG review.

#### January 2023:

- The ICANN Liaison reported that ICANN's <u>Proposed Procedure for Selecting a Top-Level Domain String for Private Use</u> was put out for public comment.
- The IRTF Chair reported that the <u>Usable Formal Methods Research Group</u> charter was approved by the IAB.
- Six Applied Networking Research Prizes were awarded for 2023.

#### February 2023:

- IANA reported that ICANN met 100% of processing goal times for the January 2023 monthly statistics report, exceeding the SLA goal to meet 90% of processing goal times.
- The IRTF Chair reported that the proposed research group on <u>Research and Analysis of Internet Standards Processes (RASP)</u> has been chartered. <u>ICCRG completed a charter refresh.</u>

# **Technical Programs and Support Groups**

The <u>Evolvability</u>, <u>Deployability</u>, <u>& Maintainability</u> (<u>EDM</u>) <u>Program</u> completed work on <u>draft-iab-protocol-maintenance</u> and held <u>an interim meeting in February</u> to discuss greasing.

The <u>IETF-IANA Group</u> meets once per meeting cycle. <u>Meeting minutes</u> are available in the Datatracker.

The <u>IETF-IEEE Group</u> met in <u>February</u> to coordinate activities between IETF and IEEE 802. <u>Meeting minutes</u> are available in the Datatracker.

The <u>IAB-ISOC Policy Coordination Group</u> met in <u>December</u> and <u>January</u> to coordinate various Internet policy related activities of both the Internet Society and the IAB.

#### IAB Statements

In November, <u>the IAB submitted comments</u> on a notice by the Federal Trade Commission on "<u>Trade Regulation Rule on Commercial Surveillance and Data Security</u>" (16 CFR Part 464).

In March, the IAB responded to the call for input from the UN Office of the High Commissioner for Human Rights on "The relationship between human rights and technical standard-setting processes for new and emerging digital technologies (2023)."

The IAB sent <u>draft-iab-path-signals-collaboration-03</u> (Considerations on Application - Network Collaboration Using Path Signals) to the RFC Editor for publication in early February 2023.

The IAB also approved <u>draft-iab-protocol-maintenance-12</u> (Maintaining Robust Protocols) and sent it to the RFC Editor for publication in February.

In January, the IAB adopted <u>draft-iab-privacy-partitioning-00</u> (Partitioning as an Architecture for Privacy).

The IAB discussed <u>draft-arkko-iab-data-minimization-principle-03</u> (Data minimization) during IETF 115 and is waiting for updates from the author before considering whether to adopt the document on the IAB stream.

### **Workshops and Workshop reports**

The first draft of the report from October's <u>IAB workshop on Management Techniques in Encrypted Networks (M-TEN)</u> was submitted to the Datatracker as <u>draft-iab-m-ten-workshop-00</u>.

In December, the IAB held a workshop on the <u>Environmental Impact of Internet Applications</u> and <u>Systems</u>. The first draft of the workshop report is available in the Datatracker as <u>draft-iab-ws-environmental-impacts-report-00</u>.
