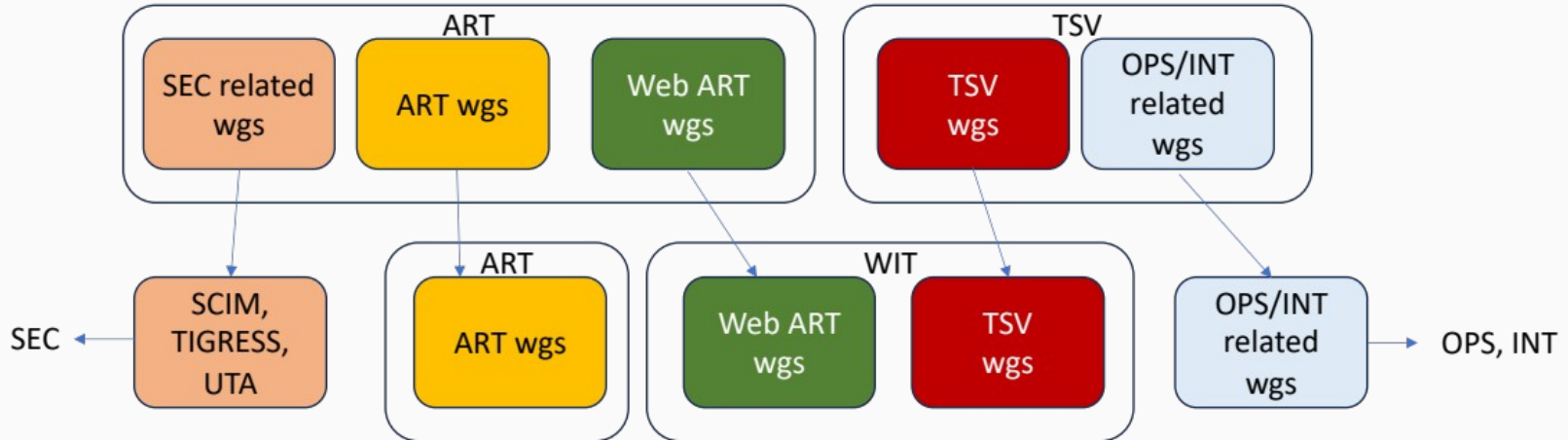

Part of **TSV** and part of **ART** will soon merge into a new area called “Web and Internet Transport” (WIT).



Timeline: by IETF 119 (with a possible transition period starting January 2024)
