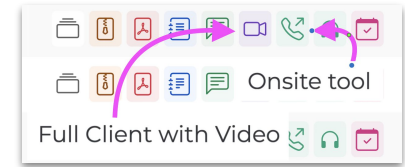

# State of Identity management discussion

- Recap: IAB proposed a program on identity management (WHODIS) just before 117 and created an discussion mailing list
- Some enthusiasm and discussion on the list about this general but very broad problem space
- No clear and concise problem statement emerged, but concrete efforts in the IETF did emerge
  - WIMSE, SPICE, ...
- IAB intends to abandon proposed program and close the mailing list
