On October 23, 2023, the IAB received an appeal from John Klensin on the IESG appeal decision on Meeting Guidance. The IAB is currently reviewing this appeal.

Appointments

In July, the IAB reappointed Tim April to the ICANN Root Zone Evolution Review Committee (RZERC).

Also in July, the IAB reappointed Russ Housley and Barry Leiba to the Community Coordination Group (CCG).

In August, the IAB sent a liaison statement to ETSI on <u>URI scheme registration for postal addresses (ETSI TS 102 818 V3.4.1 (2022-05))</u>.

In October, the IAB named <u>Deborah Brungard</u> as the new liaison manager for <u>ITU-T Study Group 15</u>. Deborah is taking over the role from John Drake, who is stepping back after serving in this role for many years. The IAB thanks John for his service.

Liaison Report Highlights

August 2023:

- The ICANN Board announced the intention to set a target date for applications for a new gTLD program soon.
- The IETF-IANA Group met via conference call. Minutes from that meeting are available in the Datatracker.
- The IRTF Chair reported that the call for nominations for the Applied Networking Research Prize (ANRP) 2024 will open in September.

September 2023:

- IANA reported that ICANN met 100% of processing goal times for the August 2023 monthly statistics report, exceeding the SLA goal to meet 90% of processing goal times.
- The IRTF Chair reported that the <u>Human Rights Protocol Considerations (HRPC) RG</u> is in the process of rechartering.

Outreach

In August, IAB created a new <u>IAB Outreach Coordinator</u> role as part of our effort to better plan, coordinate, and keep track of the Outreach activities undertaken by the IETF Leadership. The IAB has selected Dhruv Dhody to serve in the role for this year.

The IAB hosted a <u>town hall session about the IETF at the Internet Governance Forum (IGF)</u> in Kyoto. A <u>video of the session</u> is available on YouTube.

Technical Programs and Support Groups

In August, the IAB created a new Technical Program on <u>Environmental Impacts of Internet Technology (EIMPACT)</u>. The group will have its <u>first meeting during IETF 118</u> on Tuesday, November 7, 2023 from 11:45-12:45 (UTC+1).

The <u>Evolvability</u>, <u>Deployability</u>, <u>& Maintainability</u> (<u>EDM</u>) <u>Program</u> is also planning to <u>meet</u> during <u>IETF 118</u>, on Monday, November 6, 2023 from 11:30-13:00.

The <u>IAB-ISOC Policy Coordination Group</u> met in <u>September</u> to coordinate various Internet policy related activities of both the Internet Society and the IAB.

The <u>IETF-3GPP Coordination Group</u> held an open <u>interim meeting</u> in October to coordinate activities between the IETF and 3GPP.

The <u>IETF-IANA Group</u> meets once per meeting cycle. <u>Meeting minutes</u> are available in the Datatracker.

The <u>IETF-IEEE Group</u> met in <u>October</u> to coordinate activities between IETF and IEEE 802. <u>Meeting minutes are available in the Datatracker</u>.

In October, a new <u>IETF-W3C Group</u> was formed to coordinate activities between IETF and W3C.
