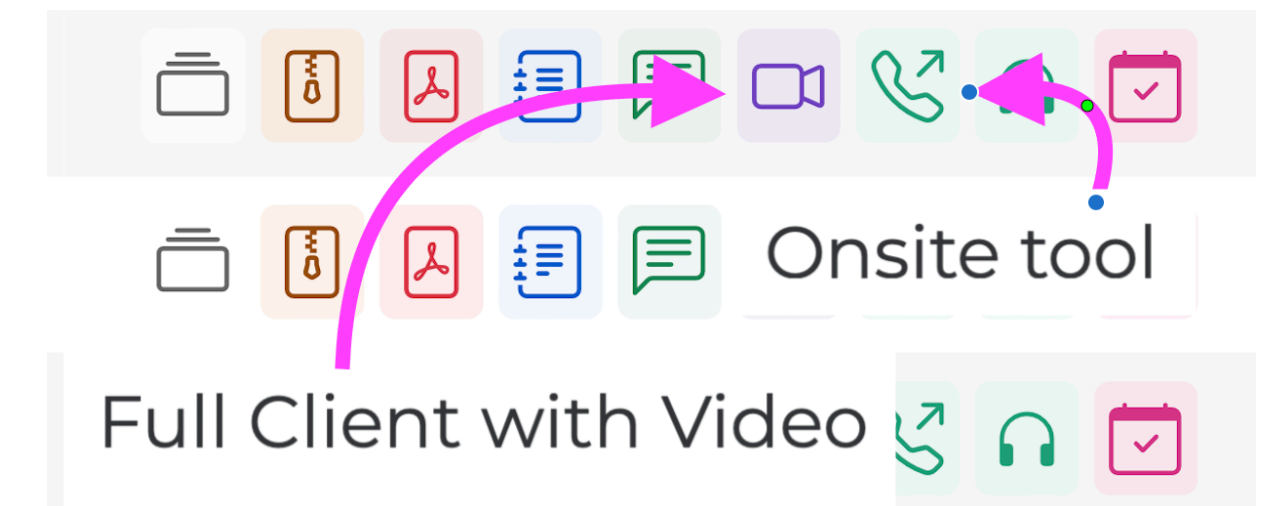
Meeting Tips
