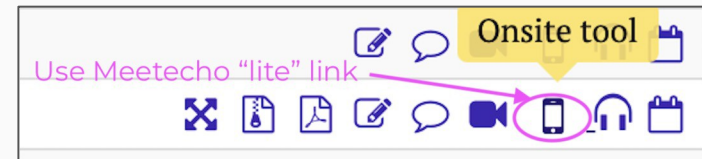
## Tips
