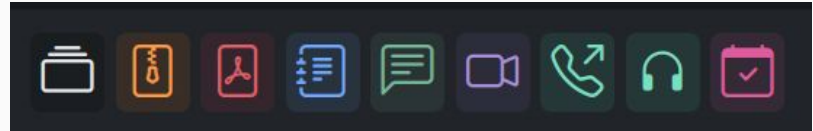
IETF 119 Meeting Tips
