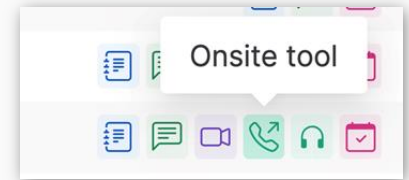

 - Authors waiting for WGLC that is dependent on re-charter
