# Note Really Well

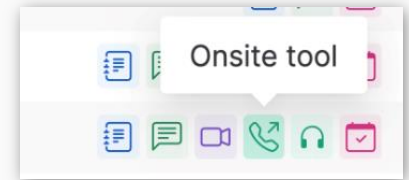
