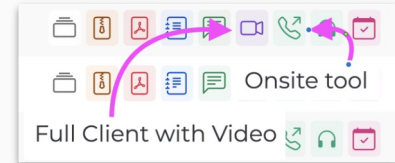

If you have any concerns about observed behavior, please talk to the Ombudsteam, who are available if you need confidentiality to raise concerns confident about harassment or other conduct in the IETF.
