- Target towards: Potential IETF participants: Network operators, enterprises, educational institutions. Regions with lower IETF participation.






## Panel @ **APRICOT**

Diversity in voices is essential for creating globally relevant standards. While APAC's involvement in the IETF has grown in recent years, participation remains uneven, with significant underrepresentation from certain countries and operator communities. Despite having the largest and most diverse internet user base, the region still lags in active participation.

The panel explored strategies to bridge these gaps, amplify operator perspectives, and encourage broader regional engagement to ensure the Internet evolves to meet the needs of all its users.

- Are we engaging operators that have the time, interest, and need?
- Operators can focus on bringing problems to the IETF
- Remote participation helps, but fees and time commitment remain challenges.
- Operators rely on vendors, but direct participation of IETFers in NOGs would be of great benefit.
- Is a new operator survey needed to learn about barriers to IETF participation?
