WG Update

- Well behind milestones
- Focused mainly on getting GIST done after return from IESG
- GIST will be send to IESG soon
- Finished QoS NSLP last call
- Need to finish all other WG items also

GIST Status

- GIST returned to WG during last IETF meeting
 - ♦ Needed further discussions and review due to IESG comments
- pre-release version 14 advertised to the mailing list on 26th june
- version 14 sent to ID editor on 9th July (only editorial changes compared to pre-release version)
- main changes are listed in the change summary (E.1) which now contains only the last set of changes
- mainly editorial apart from:
 - ♦ messages with wrong magic number are now silently dropped at the destination
 - ♦ corrected the MTU rules in 4.3.3
 - ♦ corrected rules for MA teardown when stack-proposal verification fails (5.7.1)
 - ♦ modified cookie construction (8.5)
- this handles all the open issues (including the interop tickets), with the possible exception of making the hello-id optional in the hello message.

- IESG evaluation process starts again
- WG to focus on remaining WG items
