# 0915: Status of core documents

# 0925: Outstanding issues discussion

- #1507: UTF8HDR/DSN: Remove NO-WS\_CTL from specification
  - Preferred: Refer to 2822bis. Timing issue.
  - Suggestion: Normative ref to 2822 for “text”, state in text that 2822bis is preferable
- #1518: UTF8HDR 4.1: Normalization isn't talked about. Should it be?
  - Refer to draft-klensin-net-utf8 (20:0)
  - Placement at editor's discretion. If it's removed from section 5, section 5 can be removed.

# 1000: Downgrade document

- Document: draft-ietf-eai-downgrade-05.txt
- Issues:
  - #1496: Simple downgrade procedure?
    - Section 8.1 in downgrade -05 is adequate.
- Breaking out Appendix A in a separate doc
  - Punt to mailing list
- Review before WG Last Call
  - Needs to be reviewed by implementors
- Hoping for WG Last Call before Christmas

# 1030: IMAP and POP

- IMAP: draft-ietf-eai-imap-utf8-02.txt
- POP: draft-ietf-eai-pop-02.txt
- Should we remove “upgrading”?
  - Strong consensus among those who have an opinion that we should remove it. (IMAP section 9)
- IMAP status
  - IMAP now uses ENABLE
  - IMAP document ready for wider review
- POP status
  - Mode switch, 8-commands or punt?
  - 20:0:0. Next version will have a switch.

- Discussion of whether Mailto: URL should be adopted now
  - Background document: draft-duerst-mailto-bis-04.txt (expired)
  - Question on whether we address the IRI form or the URI form
  - It's a dependency of the List- headers work in Mailinglists
