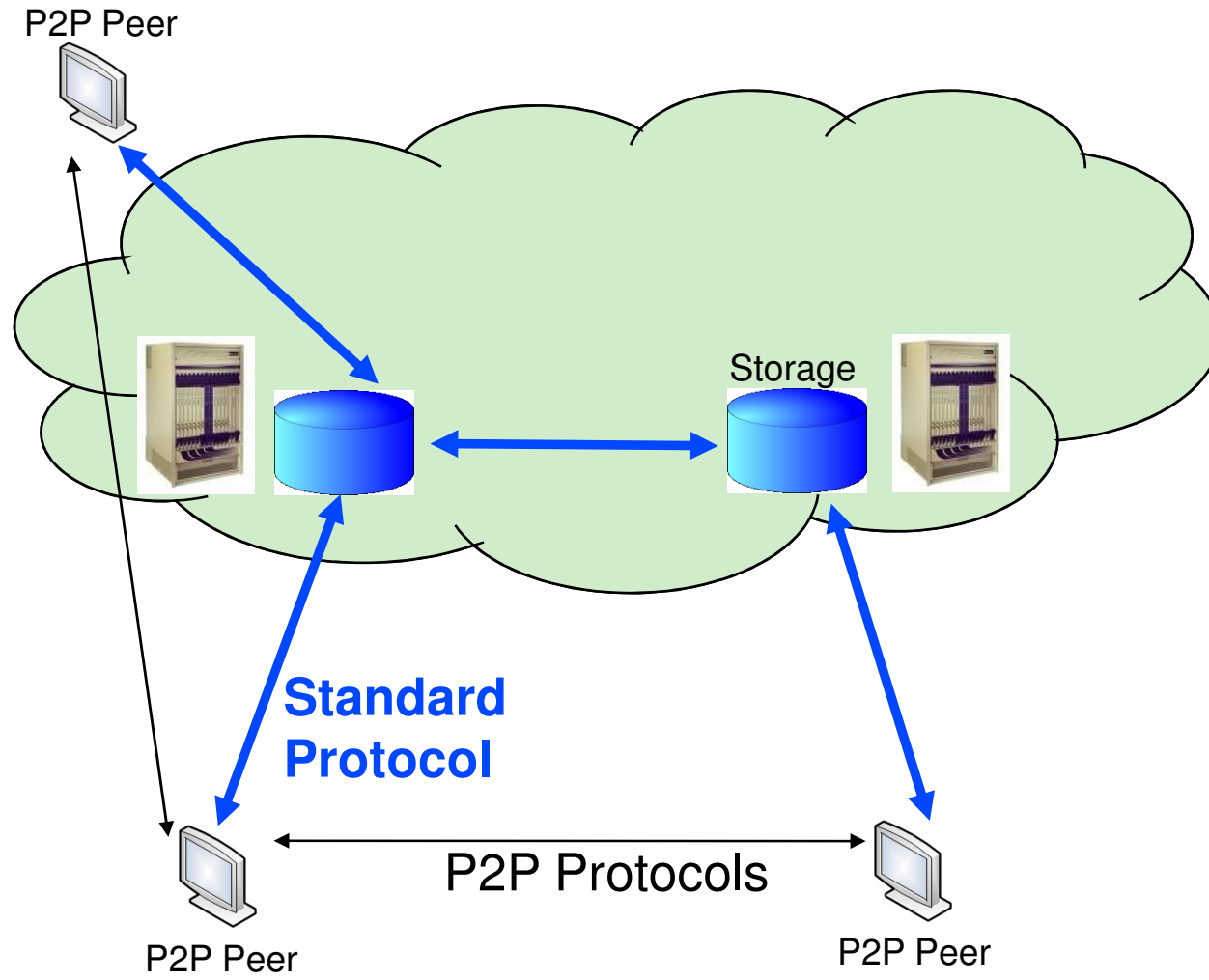

The Elephant in the Room – Illegal Content

- Any in-network storage faces the problem that a user may store illegal content
- Current charter language:
 - Potential interactions between in-network storage operators and copyright holders of content. For example, one possibility is that that an in-network storage system may have system-wide ingress and egress filters to implement copyright related policies on storing or retrieving content in the in-network storage. But this is outside the scope of this working group.

The Elephant in the Room – Illegal Content

- ISPs may be required to remove or quarantine ‘illegal content’ from storage
 - E.g. child pornography, copyright infringing content, ...
 - Detection and removal/quarantine is out of scope for DECADE
- But this shouldn’t break applications
 - DECADE should handle cases where content is removed, quarantined, and/or restored by ISP
