

Framework

- Already agreed WG document comprises aspects of framework, along with identifying data elements and messaging model, with examples.
- Suggestion to split some material that relates to other (proposed) deliverables into separate documents.
- Suggestion to add some higher level material to introduce some of the concepts and to provide an "orchestration" of the other proposed deliverables.



Proposal for Framework Restructure

- Add a new section after section 4 including some of the higher level concepts that are embedded later in the document.
- A lot of that material can be derived from earlier drafts and in particular WG presentations (and tutorial) – i.e., lots of really good visual information.
- Need to figure out what material is appropriate to be moved to relevant documents for other deliverables.

NOT suggesting to start from scratch



Proposal for Framework Restructure

 Options for revising framework to be more high level, leaving more details in other documents:

Option 1:

- Leave existing material as is as other documents are developed, that information as appropriate can be copied.
- Once we have WG documents for other deliverables agreed, we can revise the framework for consistency and remove duplicate material.

Option 2:

- Refactor now.
- Seed other proposed documents with the relevant material.



Other Proposed deliverables starting points

RTP mapping and Usage:

- Agree draft-even-clue-rtp-mapping-04.txt as baseline for WG document
- Pull requirements and other relevant material from draft-lennox-clue-rtp-usage-04

Data model:

- Use draft-presta-clue-data-model-schema-01 as a baseline, incorporating textual descriptions from draft-romanow-clue-data-model-01
- Pull relevant material from framework



Other Proposed deliverables starting points

- Signaling (CLUE & SDP):
 - Need to figure starting point considering:
 - draft-even-clue-sdp-clue-relation-01.txt
 - draft-romanow-clue-call-flow-02
- Call Flows
 - Several documents have material around this:
 - draft-romanow-clue-call-flow-02
 - draft-kyzivat-clue-telemedical-callflow-01
 - Likely we should start a new doc that reflects WG consensus and working concepts based on other revised docs
