

Processing IETF Related Requests

A look over the past 12 months.

IANA Activity since IETF-86 (March 2013 - June 2013)

Processed more than 1292 IETF-related requests (This includes new registrations and modifications to existing registrations)

More detailed breakdown:

- Reviewed 79 I-Ds in IETF Last Call and 71 in IETF Evaluation
- Reviewed 80 documents becoming RFCs (43 of the 80 documents had IANA Actions of some form)

Update on Projects and Deliverables

- Phase 2 of integration Completed!!
 - Some changes to IANA's ticketing system have been made to allow for communication of states for Last Call and Evaluation to datatracker
 - Users can now see the both the "IANA Review State" for Internet-Drafts and the "IANA Action State" for approved documents to become RFCs
 - Planning stage 3 which would include more detail about the status of expert reviews and other information for Area Directors/Document Shepherds
 - For more information about the integration see RFC 6359
- XML' ization of registries is 99% complete
 - The listing of all the protocol registries is now automatically generated from the XML'ized registries
