IETF 88

Meet if there is interest to discuss about re-chartering, i.e. adding new WG items.

Principles

- In the current set of documents, only include features or methods that
 - Have stable specifications in either IETF or XSF. In IETF this means in practice a published RFC.
 - Have some amount of real implementation and deployment.
- New functionality introduced through separate extension documents (not on current charter)
 - Relevant especially to "media signaling" topic where new work is currently in progress in both IETF and XSF (trickle-ICE, bundle, unified-plan)
