#### WG Document Status (1)

- Three documents are currently in Working Group Last Call, which ends on Nov. 8:
  - draft-ietf-bfd-on-lags-01
  - draft-ietf-bfd-mib-14
  - draft-ietf-tc-mib-02
- The WG chairs are shepherding these documents.
- Carlos Pignataro has volunteered to gauge WG consensus.

#### WG Document Status (2)

- draft-ietf-bfd-mpls-mib
  - Needs additional WG input
  - Are there implementations in progress?
- draft-ietf-bfd-generic-crypto-auth
- draft-ietf-bfd-hmac-sha
  - Awaiting implementations to progress documents.

### WG Document Status (3)

- draft-ietf-bfd-multipoint
  - Document has been stable.
  - ALU has an implementation of silent tails.
  - Other vendors have implementations in progress, also with silent tails.
- Active tail feature does not currently seem to be getting traction. Should the draft be simplified to permit it to progress?
  - One of the authors doesn't think so. ☺

#### Non-WG Documents of Interest

- draft-akiya-bfd-intervals
  - Document will not be seeking to become normative. Perhaps adopt and make informational?
- draft-mbind-bfd-redundancy
  - Received some list discussion. Authors are not going to progress it?
- draft-vgovindan-l2vpn-evpn-bfd
  - Will be presented in L2VPN on Friday. Authors may wish to present it next IETF session in BFD.
