Obsoleting RFC 2617

- RFC 2617 defines three things:
 - The framework for HTTP authentication
 - Basic Authentication
 - Digest Authentication (WGLC soon!)

Obsoleting RFC 2617

- We now have replacements for all three
 - draft-ietf-httpbis-p7-auth defines the framework
 - draft-ietf-httpauth-digest defines Digest
 - draft-ietf-httpauth-basic (not yet published) defines Basic

Obsoleting RFC 2617

- Given that, we believe that when all three make it to RFC, they can in combination obsolete RFC 2617.
- -p7 is now past IESG
- The plan is for the header to say:
 Obsoletes: 2617 (together with 7xxx and 7xxx)
- The question for this crowd: is everyone OK with this plan?

Future of Experimental Drafts

- This WG was chartered to "document a small number of HTTP user authentication schemes that might offer security benefits, and that could, following experimentation, be widely adopted as standards-track schemes for HTTP user authentication"
- "Documenting" does not just mean rubberstamping everyone's draft. And it doesn't mean that just the authors and chairs read the draft. There's the individual stream for that.

Future of Experimental Drafts

- We have four such documents: SCRAM, MutualAuth, HOBA, and RESTful.
- None but MutualAuth have received any significant review, and MutualAuth has received very little.
- What little review there is can often go unanswered for weeks.
- Altogether we're feeling very little "working" and hardly any "group". Is this likely to change?
- When we're done with Basic and Digest, our new AD will need to decide whether there is any benefit to keeping this working group.
