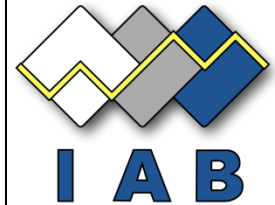

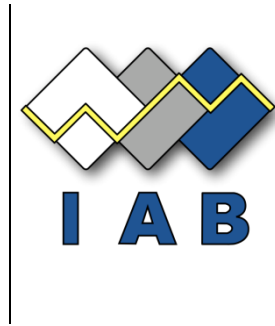
IAB Membership Update
