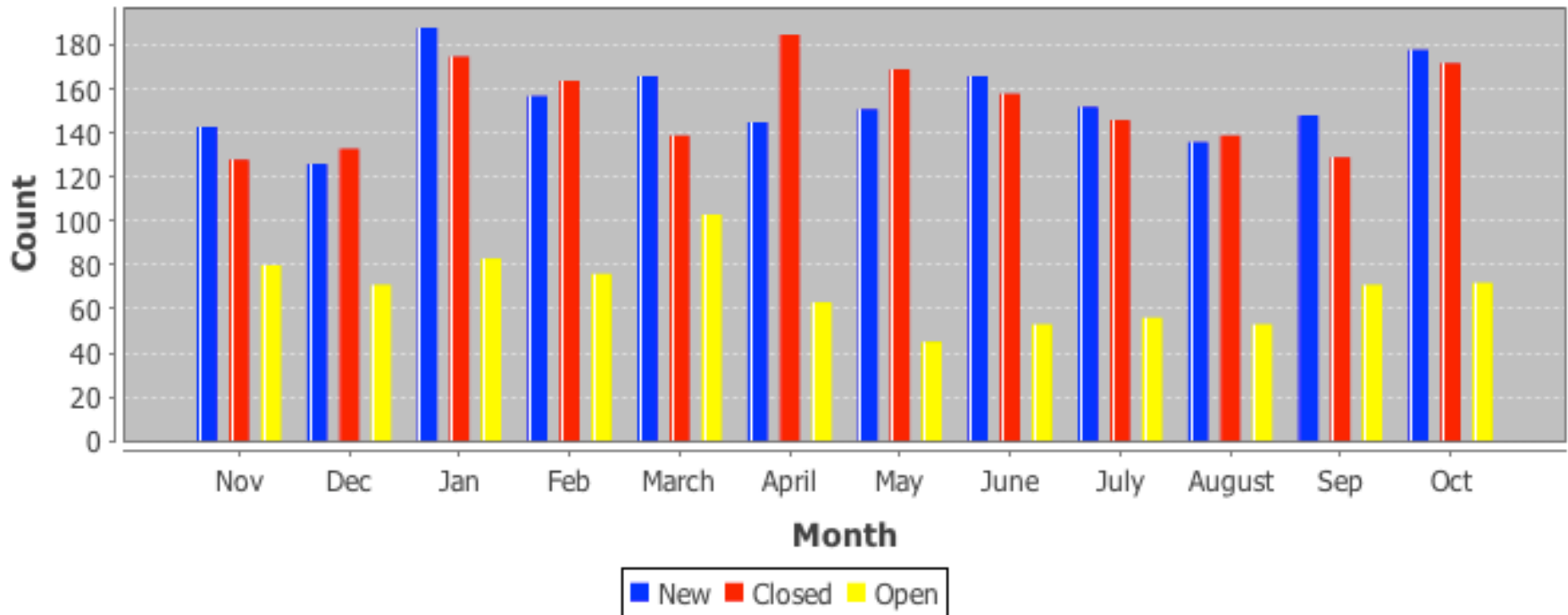

Processing IETF Related Requests

A look over the past 12 months (November 2013 – October 2014)*

Cumulative Requests Created/Closed/Open October 2014

IANA Department Activity for protocol parameter requests since IETF-90 (July 2014 – October 2014)







Processed more than 1363 IETF-related requests (This includes new registrations, modifications to existing registrations and deletions)

More detailed breakdown:

- Reviewed 111 I-Ds in IETF Last Call and 125 in IETF Evaluation
- Reviewed 82 documents becoming RFCs (44 of the 82 documents had IANA Actions of some form)

SLA Performance

- Average cumulative percentage for May 2014 through October 2014 was 99.5%

Update on Projects and Deliverables

Protocol Parameters Review

- Review by third-party is currently underway to ensure IETF policies are accurately followed in processing protocol parameter requests.
- Report will be available in March 2015

Early Allocation Expirations

- The IESG is now informed monthly of any Early Allocations via RFC 7120 that are near expiration.

2014 IANA Department Customer Satisfaction Survey

- **3rd annual survey**
- **4,400 customers invited**
- **489 respondents**
- **Satisfaction trending up in most key service aspects**
- **Plan to publish a full report in January**
