





IANA Department Activity

Protocol Parameter requests since IETF-93 (July 2015-September 2015*)

Processed more than 978 IETF-related requests (This includes document reviews, new registrations, modifications to existing registrations and deletions)

More detailed breakdown:

- Reviewed 80 I-Ds in IETF Last Call and 89 in IETF Evaluation
- Reviewed 79 documents becoming RFCs (40 of the 79 documents had IANA actions of some form)

SLA Performance

Average cumulative percentage for April 2015 through September 2015 was 98%.

The draft 2015 SLA between ICANN and IAOC for the protocol parameter work is still under review.



Update on Projects and Deliverables

Protocol Parameters Review

- Required deliverable in the proposed 2015 SLA
- Third-party review of ICANN's processing of protocol parameter requests
- Third-party auditors have reviewed the controls and sample data
- Report will be delivered to the IPROC by March 30, 2016

Defining controls for an internal review of the qualitative aspects of protocol parameter processes. Focus is to see if there are any areas of improvement in the quality of the processes and areas for more efficiency. This work will commence in the next 6 months.

- Still In Progress: RFC5226bis version 11 https://datatracker.ietf.org/doc/draft-leiba-cotton-iana-5226bis/
 - Working through changes to address discusses and additional feedback received
- Working with the IESG on defining better guidelines for changing protocol parameter contact information.
- 2015 IANA Functions Customer Service Survey completed. Report to be posted in the next few months.
