



One-implementation policy


- After requesting feedback from the WG, the following is now effective :
 - ◆ At the same time we will issue a Working Group Last Call, we will ask for knowledge of existing implementations
 - the more details provided at that time, the better
 - ◆ In the situation where an implementation exists we will proceed with submission to IESG
 - ◆ In the opposite situation, we will systematically ask the WG for reasoned opinions regarding whether we should nevertheless proceed with submission to IESG
 - ◆ We will gauge consensus on that aspect. In case consensus is in favour of proceeding with submission to IESG we will do so
 - ◆ In the opposite case, we will put the document in a "Waiting for implementation" state until information on an existing implementation is brought to our knowledge or of the WG
