



## Processing IETF Related Requests

A look over the past 12 months (March 2015-February 2016)\*

## IANA Department Activity

Protocol Parameter requests since IETF-94 (October 2015-February 2016\*)

Processed more than 1581 IETF-related requests (This includes document reviews, new registrations, modifications to existing registrations and deletions)

More detailed breakdown:

- Reviewed 113 I-Ds in IETF Last Call and 133 in IETF Evaluation
- Reviewed 133 documents becoming RFCs (68 of the 133 documents had IANA actions of some form)

Average cumulative percentage for September 2015 through February 2016 was 97%.

The draft 2016 SLA between ICANN and IAOC for the protocol parameter work is still under review.

## Update on Projects and Deliverables

#### Protocol Parameters Review

- Required deliverable in the proposed 2015 SLA
- Third-party review of ICANN's processing of protocol parameter requests
- Third-party auditors have reviewed the controls and sample data
- Report was delivered to the IPROC in March 2016
- No exceptions were reported

Internal review of the qualitative aspects of protocol parameter processes is underway. Focus is to see if there are any areas of improvement in the quality of the processes and areas for more efficiency.
