# .home

RFC7788 says:

A network-wide zone is appended to all single labels or unqualified zones in order to qualify them. ".home" is the default; however, an administrator MAY configure the announcement of a Domain-Name TLV (Section 10.6) for the network to use a different one.

Errata has been approved to change this to:

A network-wide zone is appended to all single labels or unqualified zones in order to qualify them. A default value for this TLV MUST be set, although the default value of the Domain-Name TLV (Section 10.6) is out of scope of this document, and an administrator MAY configure the announcement of a Domain-Name TLV for the network.
