# RFC 6701: Sanctions Available for Application to Violators of IETF IPR Policy

- The impact that an IPR disclosure has on the smooth working of the IETF is directly related to how late in the process the disclosure is made.
- The IPR situation is considered at key times such as adoption of the document and during last call.
- Not conforming to the IETF's IPR policy undermines the work of the IETF – and sanctions ought to be applied against offenders.
- WG Chairs are empowered to take action.
