 - The IAB or any member thereof on behalf of the IAB
 - The RFC Editor or the Internet-Drafts function
 - All IETF Contributions are subject to the rules of [RFC 5378](#) and [RFC 3979](#) (updated by [RFC 4879](#)).
- Statements made outside of an IETF session, mailing list or other function, that are clearly not intended to be input to an IETF activity, group or function, are not IETF Contributions in the context of this notice.
- Please consult [RFC 5378](#) and [RFC 3979](#) for details.
- A participant in any IETF activity is deemed to accept all IETF rules of process, as documented in Best Current Practices RFCs and IESG Statements.
- A participant in any IETF activity acknowledges that written, audio and video records of meetings may be made and may be available to the public.
