  - The intention of this whitepaper is to show guidance of the entire industry ecosystem; for operators, vendors and service providers to be able to consider common solutions of network slicing which have not been fully defined yet.
- Requested Action: (By 2021-10-15)
  - The GSMA NG kindly asks related organisations to take our whitepaper into consideration for their standardisation work on E2E network slicing as well as provide feedback on our whitepaper.

# Reminder: IPR Disclosure Process

- We follow process put in place in other groups as a result of very late IPR disclosures
  - This is not a required IETF process
- Includes
  - Polling of draft authors & contributors:
    1. Prior to moving to next step in WG process
      - a. Before an individual draft becomes a WG document and
      - b. Before a WG document goes to last call
    2. Requires IPR compliance statement from ***all*** listed in draft
- New Step:
  - Request that an IPR statement be sent to the list by any new author or contributor when added to a WG document



# Working Remote

# draft-wd-teas-ietf-network-slice-nbi-yang

- WG adoption poll – Initiated on Aug 27<sup>th</sup>, 2021
- Consensus on the need for an IETF NS NBI data model
- Reasonable support for adoption
- However, concerns have been raised on the modeling approach used in the document
  - These need to be resolved
  - Options:
    - Define a new service model from scratch
    - Use ietf-vn
    - Define a new service model by augmenting ietf-vn
